Processing:

Plastic Packaging processed from 100% pure polymeric compound, mixed with masterbatch in injection moulding technology, in closed system, beginning from the filling injection machine with raw material until the final technological processes are controlled by computer. The processing raw material temperature is between 1700 C up to 2400 C, in some cases the processing temperature can be higher. The injection moulds are equipped with hot runner systems suitable for this applications, with all types of thermoplastics recommended for the packages used in cosmetic and pharmaceutic industry

Properties:

The plastic raw materials and masterbatches are supplied by the most important producers from Europe, free from heavy metals, completely certified & guaranteed for use with food and cosmetic or pharmaceutic products. The Cream-Jar is produced conform with the European Community Standards and Directives regarding package integrity. This type of Cream-Jar is suitable for cosmetic, pharmaceutic and related products, produced to fit a highly sanitary conditions, eliminating the possibility of contamination and deterioration of the cream. The body of Cream-Jar have double walls and assure a very good prevention against moisture, UV-light, oxygen, heat and disintegration of the product. Standards of identity and quality of our Cream-Jar is given also by the Cap and Lid, who was especially created to meet the requirements regarding the tightness.

Applications:


